Provide Costello Group are currently providing a range of land access services for Powerlink's renewable energy generation project at Kidston to connect electricity transmission lines and associated switching stations to the national electricity grid.



Costello Group operatives are currently providing specialist property consultancy services to the Inland Rail ARTC Project. The services include land negotiation, land access advisory, compensation assessment and valuation services. The property consultancy covers any requirement relating to land related activities in support of the \$9.3B federally funded national infrastructure project.



Costello Group were appointed as the primary land access contractor and property advisor to deliver approximately 65+ leasehold land interests and 13+ freehold interests. Costello Group operatives delivered crucial land access negotiations, easement negotiations, acquisitions for the delivery of the major CBD station locations at Albert Street and Roma Street.



Team operatives have previously been engaged to provide property advisory services and land access negotiation services to the Queensland Gas Company (QGC). The contract was in support of QGCs Surat basin gas project and required the timely delivery of land acquisition for development and strategic property within the bounds of the Acquisition of Land Act and the Petroleum and Gas Act of Oueensland.



Team members have provided property advisory and land management in relation to Exxon Mobil's Rundle joint venture project in central Queensland. The appointment involves tenant management and advisory covering approximately 20,000Ha of land over 29 lots. Costello Group oversaw all property requirements for the assets to ensure they were commercially managed to the highest possible standard whilst encouraging local involvement and community engagement.



CG personnel were involved in advising Arrow energy across their commercial Office portfolio and Freehold Property portfolio throughout Queensland. Consisting of approximately 22,000sqm of commercial office space which required major re-positioning and sub lease/surrender program to reduce overheads. While the freehold component required consolidation of all assets with involvement of all company stakeholders and the implementation of sale and lease processes to maximise portfolio operation.
